

Now Business Offer for n3 members

Promotional Offer Terms & Conditions

These promotional offer terms form part of your Agreement with Now and should be read in conjunction with Now's 'Standard Business Terms and Conditions' which can be found at https://www.nownz.co.nz/terms-conditions/business-terms-and-conditions/ and any service schedule relating to your chosen products. In the event of any inconsistency between these Offer Terms and any other clause of the Agreement, these Offer Terms take precedence.

1. General terms

- 1. All promotional offers are valid for a limited time and are subject to change by Now without notice.
- 2. To redeem any promotional offer, the relevant promotional offer must be quoted to the Now sales agent at the time of sign up.
- 3. The promotional offers are available for new business customers with new business services only.
- 4. The below offers cannot be used in conjunction with any other offer.

2. n3 members - partnership offer

8% monthly discount on standard subscription services for the duration of the contract.

- 1. This promotion is available to all n3 members who are new and existing business customers with business services who are not in an existing promotion or contract term with Now.
- 2. This promotion is valid for the period that Now has an active partnership agreement with n3.
- 3. This promotion is only available on a 24-month contract term.
- 4. This promotion applies to Now's business broadband plans (Business Everyday-capped, Business Everyday unlimited, and Business Fibre 900) and fixed phone solutions (standard business phone lines, MS Teams calling and Now Reach).
- 5. This promotional discount excludes any other products and charges not listed above including usage, installation and hardware charges.
- 6. An 8% discount will be applied at the time the services are quoted for and will apply to standard (fixed) monthly recurring charges.
- 7. All charges are Exclusive of GST.
- 8. Standard Early Termination fees (as per 'Now's Standard Business Terms and Conditions' terms) will apply if you cancel your contract before the end of the term.



3. n3 members - special sign-up offer

\$300 sign up credit on any standard business broadband or phone services, on a 24-month contract.

- 1. The promotion period starts on 1 May and ends at 11.59pm 30 June 2024.
- 2. This promotion is only available on a 24-month contract term.
- 3. The promotion period may be extended beyond the end date, at Now's discretion.
- 4. This promotion is only available to new business customers who sign up for business services who are members of n3.
- 5. This promotion is available to business customers who sign up on Now's business broadband plans (Business Everyday-capped, Business Everyday unlimited, and Business Fibre 900) and/or fixed phone solutions (standard business phone lines, MS Teams calling and Now Reach).
- 6. The sign up credit will be applied as a one-off credit to your Now Business account.
- 7. It may take up to 3 months for Now to apply this credit to your account, and therefore your first Business invoice may have charges against it that need to be paid.
- 8. The credit is Exclusive of GST.
- 9. If you terminate your Now services during the 24-month contract period, you will be required to pay back the full amount of the credit and Standard Early Termination fees (as per 'Now's Standard Business Terms and Conditions' terms) will apply.
- 9. Any credits cannot be redeemed for cash or refunded.
